

## STATEWIDE LEADERSHIP NETWORKS

**Are parents included in the statewide leadership networks? If so, how do parents join the network?**

The Statewide Leadership Networks refers to the lead Education Service Center (ESC) or Institute of Higher Learning (IHE) and the representatives at each ESC for each network. It is not something that is able to be joined. However, each network will have resources for parents to access and parents can contact network representatives at their local ESC to ask questions or give input about the networks.

**What professional organizations, advocacy groups, or other stakeholder groups are partnering with TEA for the Statewide Leadership Networks?**

Grantees or vendors listed the organizations that they chose to partner with in their proposals. The decision regarding who to partner with is left to the grantee or vendors.

**What is the status of Network 10: Multiple Exceptionalities and Multiple Needs?**

Negotiations are ongoing. Once a grantee has been chosen, the TEA will reveal the name of the organization.

**Network 10: What guidance is available now regarding evaluating students suspected of being gifted AND having a SLD? What guidance is "in the works"? Likewise, what guidance is available for determining eligibility for special education (particularly the SLD category) when a student is suspected of being gifted AND is identified as having a disorder such as ADHD and/or LDs such as dyslexia, dysgraphia, dyscalculia?**

There is no specific statewide guidance regarding the evaluation process for students with specific disabilities who may also be GT. However, the GT Equity site notes that **district guidelines** should incorporate flexible gifted/talented (G/T) and special education (SE) assessment and identification procedures that should be individualized for each student.

Currently, we have the Progress in the General Curriculum network that has many resources on their website regarding inclusive practices. This work will also continue in the new Inclusive Services and Practices for Improved Student Outcomes network that will begin in the 19-20 school year.
